

PRIVACY POLICY

We encourage you to read our Privacy Policy before using www.libraresidence.pl as well as if you entrust us with personal data in any other form.

Our Group attaches particular importance to protecting the privacy of the Users of this website (hereinafter referred to as the Site) and the security of the processing of their personal data, as well as personal data which we have obtained and process by resources other than through our Site.

The owner of the website www.libraresidence.pl is MFC Development sp. z o.o. Bonerowska Sp. k., which operates as part of **the MFC Development Group**. The MFC Development Group is involved in residential construction projects and the companies operating within the Group share the common purpose of processing personal data. Therefore, we are joint controllers of the personal data entrusted to us. Our Group is represented by MFC Development sp. z o.o. with its registered office at 88 Wolska Street, 01-141 Warsaw, (KRS no. 0000951955, NIP: 5272988867), but each of the companies may also perform independent administration of personal data. We are linked by a data co-management agreement and reading this agreement will allow you to become familiar with our principles of co-management of your data.

We make every effort to ensure that our use and storage of personal data is carried out in accordance with applicable law, including Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons in relation to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter RODO) and other applicable provisions of Polish law, taking into account the guidelines of the Office for Personal Data Protection.

I. Security measures

1. We make every effort to use modern technical and organisational security measures to ensure the protection of Users' personal data against destruction, loss, modification or unauthorised disclosure and access.
2. Communication between Users' computers and the Site server for the duration of personal data transmission is encrypted using SSL (Secure Socket Layer) protocol, and databases are protected against unauthorised access.

3. Processing of personal data both in electronic systems and in paper form, we have implemented data protection procedures required by law, including granting access to such data only to persons obliged to maintain the confidentiality of such data and trained in the principles of personal data processing, and when we are supported by external entities in rendering services to us, we sign with them agreements on entrusting data processing.

II. Information on the processing of personal data

1. Co-administrators and contact details

The co-controllers of the personal data provided to us by you are entities of the MFC Development Group.

MFC Development Group has not appointed a Data Protection Officer, but you can contact us on all matters relating to your personal data by email: daneosobowe@mfcgroup.com.pl

2. Rights of the data subject.

Every person whose data we hold has the following rights:

- the right to access the content of his/her personal data, i.e. the right to obtain confirmation as to whether we are processing his/her data and information concerning such processing;
- the right to rectification of data where data processed by us is inaccurate or incomplete;
- the right to request erasure of the data;
- the right to request the restriction of processing;
- the right to data portability, i.e. the right to receive the personal data provided to us and send it to another controller;
- the right to object to data processed on the basis of the legitimate interest of the controller, including for direct marketing purposes;
- the right to lodge a complaint to a supervisory authority (in Poland this is the President of the Office for Personal Data Protection);
- the right to withdraw your consent at any time, where the processing of your data takes place on the basis of the consent given to us, which, however, does not affect the lawfulness of the processing performed on the basis of the consent before its withdrawal.

3. What data we process, on what basis and for what purpose.

Data collected when you use the Site

When you visit our Site we collect and use non-personal data collected by means of cookies, under the terms of the Cookie Policy you can read below.

The browser used on your device automatically sends information to our website server and temporarily stores it in a so-called log file. This results in the following information being automatically (without any action on your part) collected and stored until it is automatically deleted:

- the IP address of the Internet-enabled device sending the request;
- the date and time of access
- the name and URL of the file being downloaded;
- the website from which the request is sent (known as the URL referer);
- the browser you are using and, where applicable, the operating system of your internet-enabled computer, as well as the name of your internet service provider.

We are not able and will not be able to identify you directly from the data collected. This data is processed for the following purposes:

- to ensure a seamless connection;
- to assess the security and stability of the system;
- to detect attacks on the system.

In this context, these are functional or essential cookies that are absolutely necessary for the operation of the website.

Contact form on the Site

If you send us an enquiry using the contact form on the website, we will process the personal data provided in the form, such as your name, e-mail address, telephone number, as well as the data contained in the enquiry. The provision of this data is voluntary, but - with regard to your e-mail address - necessary in order for us to respond to your enquiry. The provision of data in a broader scope than the e-mail address may make it easier for us to understand the context of the case, as well as enable telephone contact, which in certain cases may speed up the response.

Purposes, grounds and duration of our processing of personal data:

- 1) in the case of voluntarily filling in the contact form on our website (or on the websites of other entities where we provide information about our investments) and submitting an enquiry, we process the data provided (including the data contained in the content of the enquiry), on the basis of Article 6(1)(f) of the RODO - the controller's legitimate interest, and the processing lasts until the enquiry is handled and a response is provided;
- 2) if you voluntarily complete a written contact form in which you express an interest in our offer, we process the data you provide for the purpose of providing commercial information on the basis of your consent Article 6(1)(a) RODO - data processing continues until you withdraw your consent or we determine that the data provided to us is not valid;
- 3) we may also process personal data provided in contact forms and those obtained during the performance of a contract for the purposes of so-called direct marketing. Our activities will include the provision of information about the activities of the MFC Development Group, including information about our activities, new activities and events that we organise, based on Article 6(1)(f) of the RODO i.e. the administrators' legitimate interest - processing continues until you express your objection or our legitimate interest ceases;
- 4) if you have agreed to receive commercial information from Grupa MFC Development (e.g. presentation of an offer) by means of electronic communication (e-mail, sms), additionally we will be able to provide you with commercial information containing an offer of services or products of Grupa MFC Development, on the basis of Article 6(1)(a) RODO - voluntary consent to process personal data - data processing continues until you withdraw your consent or we determine that the data provided to us is not valid;
- 5) in the course of our business activities we also process the data of our contractors and suppliers (i.e. name if it is in the company name or contact persons, postal address, telephone number, email address, NIP, PESEL, bank account number or others disclosed to us) in accordance with Article 6(1)(b) RODO i.e. for the performance of the contract and/or Article 6(1)(c) RODO i.e. performance of a legal obligation:
 - in relation to entities with which we cooperate or intend to cooperate in order to take action prior to entering into a contract at the request of the data subject or in order to perform a contract to

which the data subject is a party - we process the data for as long as the contractual relationship lasts and after its termination for the duration of the rights to assert and protect against claims;

- to comply with a legal obligation incumbent on us (e.g. tax and accounting obligations) - we process this data for as long as there is a legal obligation to store it in accordance with the regulations.

We would like to inform you that the direct marketing we carry out may be carried out by means of electronic communication (e.g. SMS, MMS, e-mail) and telecommunication terminal equipment (e.g. phone, tablet).

4. Categories of recipients of data, i.e. entities that process personal data on behalf of the MFC Development Group

In connection with our form of business activity, the data entrusted to us, depending on the purpose of the entrustment, may be transferred by us to the following groups of entities cooperating with us:

- entities that support us in services related to customer acquisition and service and contract fulfilment (e.g. external customer service office, accounting, construction contractors dealing with the presentation of properties to customers on investments, or finishing works, or corrections within the framework of complaints);
- providers of legal services, notary services, consultancy services, financial services, estate agents, courts and administrative bodies, when necessary or required by law or at your request;
- entities providing us with technical services (e.g. development and maintenance of IT systems, websites, software), or other administrative services (e.g. archiving companies);
- telecommunications companies, debt collection agencies, banks, credit reference agencies,
- postal operators, couriers, carries, freight forwarders and transport companies.

5. Additional information on the retention period of personal data

In fulfilment of the information obligation related to the collection and processing of personal data, we indicate below the standard periods for which we will keep the personal data entrusted to us:

- 1) personal data processed for the purpose of entering into or performing a contract and fulfilling a contract-related legal obligation will be stored for the duration of the contract and thereafter for the period necessary for:
 - after-sales service (e.g. complaint handling);
 - investigation or defence against possible claims;
 - fulfilment of our legal obligations (e.g. tax or accounting), i.e. for the period of the legal obligation to store such data;
- 2) personal data processed for the purposes of direct marketing of our own products, handling of an enquiry on a contact form, which are processed on the basis of our legitimate legal interest, will be processed until the data subject objects or the legitimate interest of the controller expires, whichever occurs first;
- 3) personal data processed on the basis of a separate consent will be stored until the consent is revoked or until it is determined that the data is not valid.

IV. Non-personal data collected automatically

When you visit our Site, non-personal data (e.g. type of browser and operating system used, domain address of the website from which you navigated to our Site, number of visits, average time spent on

the Site, pages viewed) may be collected automatically (i.e. as a result of the action of access devices and intermediate programs). The transmission of this data happens automatically when you access the website, the browser you are using automatically sends the information to our website's server and temporarily stores it in a so-called log file. We use this type of data to monitor the attractiveness of our website and with this data improve its performance and content. We are not and will not be able to identify you directly from this collected data.

V. Cookie Policy

By using our Site you agree to the use of cookies in accordance with this Cookie Policy.

We use cookies to track the preferences of visitors to our Site, to optimise the design of our Site, to personalise content and advertising, and to analyse traffic on our Site.

You can change or disable your cookie processing settings at any time within the settings of the web browser you are using.

Cookies are small text files used by websites to improve the user experience. By law, we may store cookies on your device if they are necessary for the operation of the website. For all other types of cookies, we need the user's consent. The legal basis for processing cookies required for the operation of the website is Article 6(1)(f) of the DPA. The user can withdraw his or her consent at any time with effect for the future by changing the setting in the cookie consent manager to inactive. Our website uses various types of cookies, but you also have the option of visiting our website without cookies. Most browsers automatically accept cookies. You can prevent cookies from being stored on your hard drive by selecting the "Do not accept cookies" option in your browser settings. Please refer to your browser manufacturer's instructions for details on how this works. You can delete cookies already placed on your computer at any time. However, if you do not accept any cookies, this may result in some features of our website being limited.

VI. Use of links/links/directions to other websites

Links/links/redirects to other websites may appear on our Site in order to provide you with access to the fullest information possible. These sites are outside of our control and MFC Development Group is therefore not responsible for their privacy and data protection practices. If you prefer to use the links provided on the Site, we recommend that you first read the privacy policy and other legal notices of the site in question.

When accessing our Site, no data is transmitted to social networks (e.g. Facebook, YouTube, Instagram, LinkedIn). Profiling by third parties is therefore excluded. The links provided are small graphic files that redirect the user to the websites of the respective social networks. After clicking on them, the user leaves our website and is redirected to our company page on the respective social network.

VII. Data processing on our social media channels

In addition to our Site, the MFC Development Group is also active on other websites and social networks (e.g. Facebook, YouTube, Instagram, LinkedIn). These portals are not operated by our Group and may only be used in the form offered by the respective operator. If you visit our profiles on these portals, you accept the terms and conditions of use of the respective portal operator and have been informed about the data processing, including the transmission of the data to us. Depending on the specific processing you have consented to with the portal operator, the purpose of the third-party portal is for us to receive certain information about you when you interact with us on the portal (e.g. you are a fan of our Facebook page, follow our page on Instagram or subscribe to our YouTube channel). The legal basis for the processing is your contract with the portal operator or your consent to voluntarily provide us with the data. Your interaction with us on the portals is voluntary. If you send us additional information (e.g. in a short message on the portal), this will be used to respond to your request. We also use the information

we receive to analyse visits and reactions to our profile and to improve its design. However, we only use pseudonymised data and the anonymous statistics generated from it.

Please note that the information you share online, including through our social media sites, is available worldwide and can be found through search engines and combined with other information that can be used to create personal profiles about you. Information posted online, including photos and videos, can be easily copied and distributed. There are specialist archiving services that aim to permanently document the status of specific websites on specific dates. This may mean that information published on the Internet can still be found on the original site, even after it has been deleted. As our website is publicly accessible on the Internet, it cannot be ruled out that other persons or companies will process this data or use it for other purposes. We would like to point out that, on our part, we have taken technical measures to ensure the protection of your data, but we cannot guarantee its full security if it is used by other Internet users in the event that you publish it on the Internet. VIII. YouTube

Our website uses the YouTube plug-in, which is operated by YouTube LLC, headquartered at 901 Cherry Avenue, San Bruno, CA 94066, USA ("YouTube"). All videos uploaded to our website are displayed in privacy mode when the page is opened. This means that no information about website visitors is collected and stored by YouTube until they play the video. A connection to the YouTube provider will only be established if an action is taken (the video clicked). In this case, you consent to the processing of your personal data in accordance with Article 6(1)(a) RODO and Article 49(1)(a) RODO. The Court of Justice of the European Union has found the US to have an inadequate level of data protection compared to EU standards. In particular, there is a risk that your data may be processed by the US authorities for control and monitoring purposes, most likely without you having any legal means of defence against such actions. You may withdraw your consent at any time with effect for the future by changing your settings in the Cookie Consent Manager. You may opt out of data collection by YouTube by changing the Marketing Cookies option in the cookie settings to inactive. In this case, the videos cannot be shared. If you click on "Accept only necessary cookies", the transmission described above will not take place. If you have a YouTube account and do not want YouTube to collect data via our website and link it to your account data stored on YouTube, you must log out of YouTube before visiting our website. IX. Analytical activities

Google Tag Manager

Our website uses Google Tag Manager. This service allows you to manage the tags of web pages via an interface. Google Tag Manager only implements tags. This means that no cookies are used and no personal data is collected. Google Tag Manager runs other tags, which in turn may collect data. However, Google Tag Manager does not have access to this data. If the service has been deactivated

at the domain or cookie level, it remains active for all tracking tags as long as they are implemented in Google Tag Manager.

Google Analytics

Our website uses Google Analytics, a website visit analysis service provided by Google Inc. based in Mountain View, USA ("Google"). Google Analytics uses cookies to help analyse your use of the website. The information collected by cookies about the use of this website is:

- browser type/version,
- operating system used,
- URL referer (page previously visited),
- the hostname of the accessing computer (IP address), and
- the time of the server request,

these are usually standard data sent to a Google server in the USA and stored there. However, due to the use of IP anonymisation on this website, your IP address will be truncated in advance by Google in member states of the European Union or in other countries which are parties to the Agreement on the European Economic Area. The full IP address is sent to a Google server in the USA and shortened there only in exceptional cases. Please note that the code "anonymizelp" has been added to Google Analytics on our website to ensure that IP addresses are collected in anonymised format (so-called IP masking). You can prevent data collection by Google Analytics by following the link provided under "Cookies" and changing your previous entries. Google reCAPTCHA

We use the reCAPTCHA function from Google Ireland Limited, Gordon House, 4 Barrow St, Dublin, D04 E5W5, Ireland ("Google") on our website. This feature is primarily used to distinguish whether the input was entered by an individual or the result of excessive automated processing. The service involves sending the IP address and other data required by Google for the reCAPTCHA service to Google. The legal basis for the processing of your personal data by Google reCAPTCHA is your consent expressed in the cookie consent manager in accordance with Art. 6 section 1 letter a) GDPR and Art. 49 section 1 letter a) GDPR. You can withdraw your consent at any time with future effect by changing your settings in the Cookie Consent Manager. The purpose of data processing is to establish individual responsibility on the Internet and to prevent abuse and spam. The use of Google reCAPTCHA may also result in the transfer of personal data to Google LLC servers in the USA. The Court of Justice of the European Union has found the USA to be a country that does not have an adequate level of data protection compared to EU standards. In particular, there is a risk that your data may be processed by US authorities for control and monitoring purposes, most likely without you being able to exercise legal remedies against such activities. Google Ads

Our website uses the online advertising program Google Ads and, within Google Ads, the conversion tracking service of Google Ireland Limited, Gordon House, 4 Barrow St, Dublin, D04 E5W5, Ireland ("Google"). We use Google Ads to draw attention to our attractive offers on external websites via advertising media (so-called Google AdWords). We may determine the effectiveness of individual advertising activities in relation to particular advertising campaigns. Our goal is to show you interesting advertising, make our website more interesting for you and fairly calculate your advertising costs. A conversion tracking cookie is placed when a user clicks on an ad placed by Google. These cookies typically expire after 30 days and are not used to identify individuals. If you visit certain pages of this website and the cookie has not yet expired, we and Google can identify that you clicked on the ad and were redirected to our site. Google Remarketing

Our website uses Google remarketing to manage advertising campaigns and measure advertising effectiveness. Facebook pixel

We use a tracking pixel from Facebook Inc., 1601 S. California Ave, Palo Alto, CA 94304, USA ("Facebook") on our website. This pixel is used to track the behavior of users who are redirected to our website after clicking on a Facebook ad. This allows us to track the effectiveness of Facebook ads for statistical and market research purposes. The data collected in this way is anonymous to us, which means that we have no insight into the personal data of individual users. However, this data is stored and processed by Facebook, of which we hereby inform you to the best of our knowledge. Facebook may associate this data with your Facebook account and use it for its own advertising purposes in accordance with Facebook's personal data policy <https://www.facebook.com/about/privacy/>.
